Get in on the action as approximately 1,000 athletes, along with coaches, officials and family members, travel to Savannah for one of the most highly-anticipated events in the sport of baton twirling; the **2010 U.S. National Baton Twirling Championships**, which include the Festival of the Future for beginner and intermediate athletes, and the International Cup Qualifier, for athletes who want to qualify for the 2011 International Cup. These high-profile events are sponsored by the United States Twirling Association (USTA) and will take place July 12-17, 2010 at the Savannah Civic Center in Savannah, Georgia.

Most of the athletes are between the ages of 6 and 24 and will be looking for baton twirling costumes and supplies, as well as athletic apparel and competition keepsakes. More than 90-percent of the participants come from outside the state of Georgia. They will be looking for clothing, accessories, artwork, gifts and souvenirs to remind them of their visit to Savannah.

- Exhibit hours: 8:00 a.m - 5:00 p.m. (May be adjusted depending on competition schedule.)
- Daily booth fee is \$250
- Exhibitors who exhibit for all six days will receive one day free for a total of \$1,250 instead of \$1,500.
- Exhibitors who exhibit for all six days will receive a FREE quarter page ad in the U.S. National Baton Twirling Championships Program, or a \$125 credit toward a larger ad. Ad deadline is May 15, 2010.
- Six-day exhibitors will receive a FREE online ad in the June 2010 issue of USTA News & Views, a monthly eNewsletter, with a link to the exhibitor's Web site. Ad deadline is May 15, 2010.
- Exhibitors will receive one table with contract. Additional tables are available if requested in advance at a rate of \$25 per table.
- Deadline for receipt of exhibitor contract and non-refundable deposit of \$200 is May 1, 2010.
- Total payment must be received by June 1, 2010.
- Booths may be set up after 3:00 p.m. on July 11, and must be disassembled by end of competition on July 17.
- USTA has contracted with and granted exclusive rights to a single vendor to provide sweatshirts, T-shirts, jackets and other garments with the **official competition name and logo**. Violation of this contractual agreement by you will result in the revocation of your right to exhibit at this event and all exhibitor fees as per the Vendor/Exhibitor Agreement below, will be due and non-refundable.
