## **LET YOUR DREAMS TAKE FLIGHT** At the 61st Anniversary U.S. National Baton Twirling Championships

Twirling dreams will take off this July, when USTA hosts the 61st Anniversary U.S. National Baton Twirling Championships, July 10-13, in Fairborn, Ohio, a suburb of Dayton. The area is an aviation mecca, rich with aviation history and innovation. (*Learn about the area's aviation* and other attractions on <u>page 11</u>.)

USTA is excited to debut a new, fourday format for these National Championships, which will be held at Wright State University, home to the annual Winter Guard International (WGI) Sport of the Arts World Championships.

The U.S. PreTrials, National individual and group events, and the Collegiate Championships will be held in the Nutter Center arena, while the Festival of the Future individual and group events will be held in the adjacent McLin Gym. (See the event schedule below.)

"This four-day format will make it easier for athletes, families, coaches and judges to enjoy Nationals and Festival with less time away from home and work, less money spent on food and accommodations, and more time to enjoy summer," said USTA President Karen Cammer.

## NO LIMITS FOR Monahans High School Twirlers



Like many high school twirlers, Hope Santiago loves performing for her school, Monahans High School in Monahans, Texas.

"The best thing about it is going out there and performing and showing everyone what you can do," said Santiago, who is a freshman this year.

She and her fellow twirler, Cheyenne Simonton, who is also a freshman, perform at parades, pep rallies and football games with the MHS Lobo Marching Band. They do one, two and three baton and a variety of partner exchanges, which always impress the hometown fans, as well as those from the opposing schools.

"They're just amazed," Santiago said. "They come up to us and say 'Oh my gosh, you're so awesome. That's amazing!"

Part of the reason their performances are so impressive is the fact that <u>Santiago performs from her</u> <u>wheelchair</u>. She was born with a condition called Caudal Regression Syndrome, a disorder that impairs the development of the lower, or caudal, half of the body.

"I'm missing some of my spine and my pelvic bones," Santiago explained matterof-factly. "So I don't have hip muscles and I'm not able to stand at all."

But that didn't stop her from starting baton twirling at age seven with coach Cari Cutbirth-Martinez, director of Famous Wolf Twirling in Monahans.

"Hope does not let her disability define her in any way," said Cutbirth-Martinez. "She wants to do everything, try everything. She is one of the most courageous kids I've ever met."

Santiago says Martinez always treats her the same way she treats all of her twirlers.

"I'm just the same as all of the other girls," Santiago said.

Martinez encouraged Santiago to try out for twirler at her high school, where she was paired with Simonton last fall. They've known each other since elementary school, but had never twirled together. <u>Santiago says she is grateful</u>



to have Simonton as a twirling partner. "It's going really good," she said. "Cheyenne treats me as an equal."

Baton twirling is just one of Santiago's many and varied interests. She has an artistic side and loves drawing and painting. She's also a multi-sport athlete who competes in wheelchair racing and shot put through the Texas Regional Para Sport organization. Nothing if not humble, Santiago left it to her mother, Stella, to mention that Hope has competed nationally



the past two years, winning a total of ten gold medals and breaking two national records, one in wheelchair racing and the other in shot put.

"I so proud of her!" Stella Santiago

said. "She's a go-getter, let me tell you! She doesn't let anything stop her!"

Hope Santiago has big goals for her future too. After high school, she plans to attend college and pursue a career as a pediatrician. Over the years, she has been inspired by the doctors and nurses who have treated her, and she wants to help children who face challenges like she has.

"Since I'm in a wheelchair and went through it, I can help them out and guide them through things," Santiago said.

She hopes that everyone will try to live their lives without limits.

"My message to everybody is whether you have a disability, or don't have a disability, go out there and do whatever you'd like to do."

# **USTA launches new Level II Judges Workshop**

USTA has developed a new, hybrid Level II Judges Workshop that will make it easier for more people to participate in Level II Judges training. The hybrid training features a one-day, in-person workshop preceded by an online educational module that participants complete prior to the in-person workshop. USTA still offers the traditional, two-day, in-person Level II Judges Workshop.

"We recognized that a two-day workshop was challenging for some of our members to participate in because of travel time and costs," said Kathy Butera Fanney, USTA Judges Department Director. "We wanted to use technology to make it easier for more of our members to participate in, and be better prepared for, the Level II Judges Workshop. This educationally sound training provides our students with the convenience of online learning coupled with a face-toface collaborative learning environment."

Led by Butera Fanney, the Judges Department worked with Monica Lee, USTA's Media and Technology Specialist, to develop a Level II online learning module, which helps prepare members for the Level II in-person workshop. Members can complete the online module at their own pace prior to participating in the in-person workshop.

That's what USTA Professional member Alexandra Beresford did last fall.

"I really enjoyed that I could do half the course on my own time, usually late at night on weekends," Beresford said. "After finishing the online portion, I think reviewing the material in class with the instructor and other class members really solidified the lessons. The in-class time was invaluable for learning and becoming a better judge, coach and twirler, but I think the online portion helped cover the basics of the material so the in-class time could be used most effectively."

After completing the online module, Beresford attended the first-ever, one-day, Level II workshop, which was beta-tested during a workshop hosted by the Colorado Baton Council on Nov. 10, 2019. Clinician Krystal Mignone, who has taught dozens of Level II and Level III Judges Workshops, thought the new format worked well.

"I was extremely impressed with how well-prepared all of the attendees were for this workshop," Mignone said. "We were able to zero in on the practical judging and testing scenarios with very fruitful and lively discussions. As it was our first time piloting the hybrid workshop, I was not sure what to expect. So I let the attendees drive the pace. I definitely feel as though this new format will make it easier for people to attain their certification."

I was also the D.A.R.E. spokesperson and traveled and twirled all over Arizona to encourage children stay off drugs, etc. I believe if a child stays busy and has goals they will stay on track. This is why I am a full-time coach today. I have started twirling programs in every high school in Northern Arizona. My group has performed and traveled all over the United States. . I love the sport of baton twirling and coaching twirlers every day.

I wanted to be the Coaches' Department Director because I love to coach and want our wonderful sport to continue to grow. I also want to share my knowledge of how to create a successful twirling group and how to teach each student by age and progression. I

am going to continue the work of Kathy Forsythe, my predecessor in the Coaches' Department, and I would like to open up more communication with our younger and newer coaches. I am looking forward to talking with people and learning from them too. Coaches need to work together.
