OHIO TWIRLER RECEIVES CONGRESSIONAL RECOGNITION

Last November, Mikayla Schuller got quite a surprise. The 16-year-old from Willoughby, Ohio received a Certificate of Congressional Recognition and Achievement from U.S. Congressman David Joyce in recognition of her accomplishments in the sport of baton twirling. Schuller also received a United States flag that was flown over the U.S. Capitol.

“At first I was shocked,” said Schuller, who learned of the award when her school’s vice principal made an announcement during her chemistry class. “My teacher thought it was amazing and gave me a hug and my classmates were excited. I was honored to receive a Congressional certificate.”

Schuller received the award in part for winning the gold medal in Jr. A 2-Baton at the WBTF International Cup, held last summer in Limoges, France. She also competed in IC 3-Baton and in the Grand Prix Team competition with her team, Intrepid.

Twirling has been a big part of Schuller’s life since she was a little girl taking ballet and tap lessons at a local dance school in Dover, Ohio.

“She came home one night and said ‘Mom, I want to take a baton class. It looks like a lot of fun,’” recalled Schuller’s mother, Melissa. “After her first baton class the teacher spoke to me and said she wanted to move Mikayla up a class. All I could say was ‘Ok!’”

When the family moved to Willoughby, Schuller joined Showstoppers where she took from Audrey Moore and Leighann Hay. Ten years later she still twirls on a team for Showstoppers, but her current coaches are Cheryl Wimberley and Karrissa Wimberley.

“Twirling has been such a wonderful part of our life,” said both Mikayla and Melissa.

But baton twirling is just one of Schuller’s talents. She’s a junior at Willoughby South High School (which does not have twirlers) so she plays mellophone in the school’s competitive marching band. She plans to study either mechanical or chemical engineering in college, while also fulfilling her dream of being a collegiate twirler.

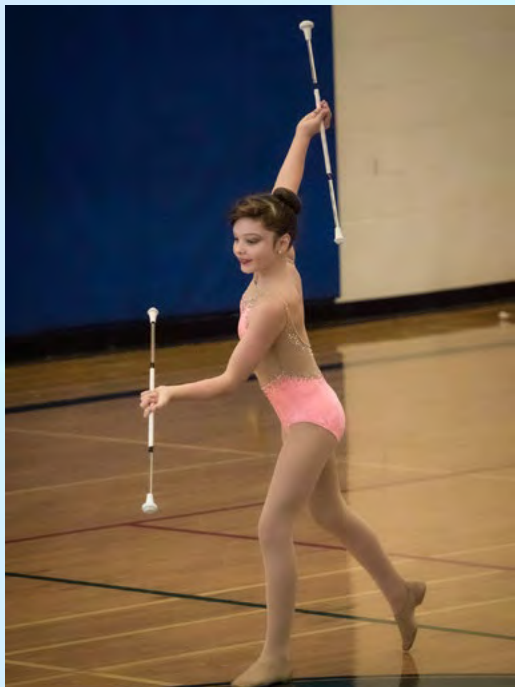

PURDUE TWIRLING CLINIC: WH

When Alicia Dennie was seven years old, her parents took her to her first Purdue football game. They also took her to Slayter Hill to see the Purdue All-American Marching Band perform before the game. That's where Dennie first saw the Purdue twirlers and a dream was born. Seven-year-old Dennie told her mom, Terri Dennie, that she wanted to twirl at Purdue!

The next summer, Dennie's mom signed her up for lessons with the local parade corps, Daphne's Dolls. Dennie loved it and Coach Daphne saw that she had some potential. At age nine, Dennie started competitive twirling.

After that first competition year, Terri Dennie contacted Purdue about a clinic or a chance for her daughter to work with the twirlers. The coach at the time invited Alicia and her twirling partner, Jillian Smith, to Purdue for a lesson. The girls had a lesson on the steps of Hovde Hall with the featured twirlers at the time.

They all loved it.

When talking with the coach Terri Dennie suggested a twirling clinic of some sort. She explained that she had paid \$30 for her son to do a two-hour basketball clinic and her daughter to do a two-hour cheer clinic that included instruction and a T-shirt. Terri Dennie was sure a Purdue twirling clinic would be a hit.

After the Dennies got back home, the coach contacted Terri to see if they would host a clinic in Plymouth, Indiana. Terri got to work. With the help of Daphne, local businesses and friends, they were able to host the clinic that attracted 49 twirlers from around the area. Each twirler received a T-shirt and a photo with the Purdue Twirlers. In addition, the event raised \$1,000 which was donated to the Purdue twirling program.

The clinic has changed venues over the years, but it is still in Plymouth and the local Purdue Alumni Club is a huge help. The numbers have grown from 49 to 71

in recent year.

Three years ago Alicia Dennie's dream came true, and she became a featured twirler at Purdue. She was a Silver Twin her freshman year and now has been Miss Boilerette for the past two years. She is now an instructor at the event she and her mother helped to create.

The 12th Annual Purdue Twirling Clinic was held in September 2019 and attracted 110 twirlers between the ages of three and 17 who came from Indiana, Michigan, Ohio and Wisconsin. The event was a great success and watching the little ones interact with the college twirlers was inspiring. Look what a baton mom can do with a little help from her community and a daughter with a dream!

Alicia Dennie and her former twirling partner, Jillian Smith, now direct the local parade corps, which is called The Dolls. This past summer they had 72 twirlers who participated in lessons from May to August and performed in parades and

other local events. Dennie and Smith continue to be role models for young girls with big dreams. Alicia Dennie achieved her dream of twirling at Purdue and the discipline she learned from twirling has helped make her the person she is today. She will graduate in 2021 with a degree in pre-dentistry and will then go on to dental school.

This joint venture will raise the profile of the sport of baton twirling and bring us closer to Olympic recognition!

As a result, international competitions that you may be familiar with, including the **WBTF World Championships** and **International Cup**, will be changing during the next three years. Please see the calendar below and read the following explainer for important details about these exciting developments!

IN 2020:

- ▶ The last **WBTF World Baton Twirling Championships**, August 2020 in Riccione, Italy
 - ▶ USTA athletes will qualify at the U.S. Trials, March 27-29, 2020, in Lawrenceburg, Indiana.

IN 2021:

- ▶ The first **IBTF World Baton Twirling Championship** and **Nations Cup Competition** (Replaces the Grand Prix and International Cup.)
 - ▶ USTA athletes will qualify at the 2020 National Championships, July 14-18, 2020. Watch for the USTA **World Baton Twirling Championship and Nations Cup** Qualifier Manual coming soon.

IN 2022:

- ▶ The first **IBTF World Freestyle Championships** (Replaces the WBTF World Baton Twirling Championships)

2021 IBTF WORLD BATON TWIRLING CHAMPIONSHIP

- ▶ Previously known as the Grand Prix and/or International Cup. (Elite Level.)
- ▶ **For Elite level individual athletes, pairs, teams and groups.**
- ▶ Disciplines to be offered: Solo, 2-Baton, 3-Baton, Artistic Twirl, X-Strut, Duet, Artistic Pair, Twirling Team, Artistic Team, Twirling Corps and Artistic Group.

USTA athletes will qualify for the 2021 IBTF World Baton Twirling Championship in the following events during the 2020 National Championships, July 14-18, 2020, in Stockton, California:

- ▶ **Solo, 2-Baton, 3-Baton, Artistic Twirl**
Three (3) athletes, plus 1 alternate (reserve) allowed per discipline / per age group / per federation (USTA)
- ▶ **Duet and Artistic Pair**
Three (3) pairs, plus one (1) alternate (reserve) per discipline / per age group / per federation (USTA)
- ▶ **Artistic Team and Artistic Group**
One (1) Team / Corps / Group. Two (2) alternate athletes allowed. Alternates (reserves) are considered as part of a federation's contingent.
- ▶ **Please note:** A separate qualifying process for X-Strut, Twirling Team and Twirling Corps will be announced soon.

2021 IBTF NATIONS CUP

- ▶ Previously known as the WBTF International Cup (A and B levels).
- ▶ **For A and B level individual athletes, pairs, teams and groups.**
- ▶ A and B levels are determined by Content Restrictions and athlete proficiency.
- ▶ Disciplines to be offered: Solo, 2-Baton, 3-Baton, Artistic Twirl, X-Strut, Duet, Artistic Pair, Twirling Team, Artistic Team, Twirling Corps and Artistic Group.

USTA **A level athletes** will qualify for the 2021 IBTF Nations Cup in the following events during the 2020 U.S. National Baton Twirling Championships, July 14-18, 2020, in Stockton, California:

- ▶ **Solo, 2-Baton, 3-Baton, Artistic Twirl**
Three (3) athletes, plus 1 alternate (reserve) allowed per discipline / per age group / per federation (USTA)

THE SPORT OF BATON TWIRLING!

► Duet and Artistic Pair

Three (3) pairs, plus one (1) alternate (reserve) per discipline / per age group / per federation (USTA)

► Artistic Team and Artistic Group

One (1) Team / Corps / Group. Two (2) alternate athletes allowed. Alternates (reserves) are considered as part of a federation's contingent.

Please note: A separate qualifying process for X-Strut, Twirling Team and Twirling Corps is explained [HERE](#).

2022 IBTF WORLD FREESTYLE CHAMPIONSHIP

- Previously known as the World Baton Twirling Championships in Freestyle, Freestyle Pair and Freestyle Team.



FAQs and additional information

QUESTION What is the difference between **Artistic Team** and **Freestyle Team**?

ANSWER "Artistic Team" defines the name of the Team discipline done to music of personal choice for the World Baton Twirling Cham-

pionship. "Freestyle Team" defines the name of the Team discipline done to music of personal choice for the World Freestyle Championship.

- To those with an NBTA background "Artistic Team" would

relate to "Dance Twirl" team (since NBTA Twirling Teams perform to a standard piece of music.)

- To those with a WBTF background, the difference between "Artistic" and "Freestyle" Team is in name only.

QUESTION What is the difference between "Artistic Group" in the World Baton Twirling Championship and the Nations Cup since they both are required to use the B Level Content Restrictions?

ANSWER The difference is the proficiency level of the groups. Athletes who have the proficiency level to compete in championship/elite team or group do not belong in the Nations Cup.

- The Nations Cup is for the team or group of B and A Level proficiency.
- The B Level Content Restrictions ONLY determine CONTENT in Artistic Group.
- B Level, A Level, and Elite Level categories determine PROFICIENCY. PLEASE REMEMBER what is stated in the Rules Document:

The 2021 NATIONS CUP is a Tier II Competition for the development of athletes around the world. *USTA will only take A Level athletes to the Nations Cup.*

Here is IBTF'S philosophy statement for an equitable competition among Nations Cup athletes:

There will be two levels of competition in the Nations Cup: Level B and Level A which are determined by Content Restrictions and the athlete's proficiency.

It is the responsibility of the coach and athlete to enter the appropriate level in the Nations Cup based on the athlete's true proficiency of skills and experience. The IBTF expects that all member countries will respect and honor these levels in order to uphold the integrity of international competition and promote an honest competitive environment.

By reviewing the Content Restrictions that are in place, athletes should enter the appropriate level based on their proficiency and competitive achievement. Athletes who compete at higher levels throughout the year in their respective countries, SHOULD NOT have routines "watered-down" in order to meet the content restriction requirement to compete at a lower level competition.

Any athlete who has placed in the semi-finals/finals at a World Championship in any discipline may not compete in any B Level discipline at the IBTF Nations Cup.

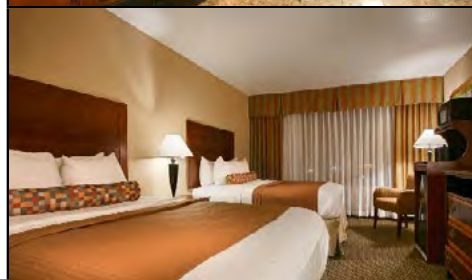

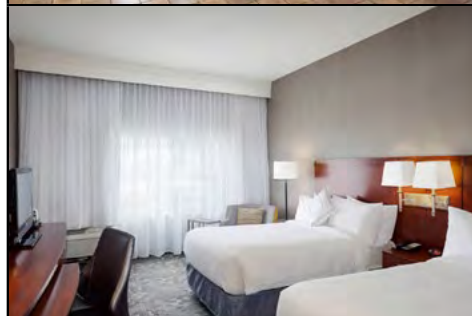
